How it works

- Each applicant must complete the entire application form accurately.
- Your application will be reviewed by the Events Team who will give you a deadline for payments upon acceptance.
- Food stalls will be required to submit all requested documentation within 7 days of application being received.
- Upon acceptance, a retainer's fee will be required immediately to secure your place.
- The £150 retainer fee is applicable **for food stalls only**. This will be refunded within 14 days upon the successful completion of the event, providing stalls are left as found and the trader has not caused Annoor Centre CIC to incur additional costs.
- A non-refundable deposit will need to be paid by a specified deadline to confirm your booking. If payment is not received by the deadline provided in the application correspondence, the stall will be offered to the next applicant on the waiting list.
- The deposit will be deducted from the overall stall fee.
- Parking onsite is limited to 1 vehicle per stall.
- If many applications are received, then a waiting list will be compiled. If anybody drops out the next applicant on the list will be contacted.

Vendor Information

- Each vendor will be given space under a marquee provided by Annoor Centre CIC.
- Stall size is 2 metres wide for regular and food stalls
- The designated henna and face painting area can fit x1 6ft table, a pull-up banner and 2 chairs.
- You are required to provide your own tables and chairs.
- All equipment must fit within the agreed parameters.
- There are additional costs if you wish to hire power from Annoor Centre CIC.
- Stalls that require electricity must state the requirement on the form. Please note there will be a limit to the number of stalls with power and this will be at an additional costs.
- You will be responsible for your own stall signage, including stall name, such as banners, posters etc.
- Please note, you will only be permitted the space that you are allocated. Any extra items which are outside of agreed parameters will be removed.
